## The NDC Partnership brings together developed and developing countries and institutions delivering on ambitious climate action to help achieve the Paris Agreement, advancing sustainable development.

In 2015, the world endorsed the Paris Agreement and the 2030 Agenda for Sustainable Development. These historic agreements presented countries with an unprecedented opportunity to drive global sustainable development through strong climate action, improving livelihoods while building a low-emission, climate-resilient world. Signaling their commitment to the Paris Agreement, countries increase the ambition of their Nationally Determined Contributions (NDCs) every five years.

Launched at COP22 in Marrakesh in 2016, the NDC Partnership was founded on the idea that technical assistance, expertise and financing for climate action were not being deployed in an effective or coordinated way to maximize efforts to achieve the goals of the Paris Agreement and drive sustainable development — and that greater support was urgently needed. Since inception, the NDC Partnership has facilitated collaboration between governments, international institutions, non-state actors and other partners to provide timely support and accelerate NDC implementation, increasing overall ambition. We leverage member resources to help countries prepare robust NDCs in line with Long-Term Low-Emissions Development Strategies (LT-LEDS).

## The NDC Partnership Today

The NDC Partnership is a global coalition, bringing together 250 members, including more than 130 countries, developed and developing, and more than 110 institutions to deliver on ambitious climate action that helps achieve the Paris Agreement and drive sustainable development. Governments identify their NDC implementation priorities and the type of support that is needed to translate them into actionable policies and programs. Based on these requests, the membership offers a tailored package of expertise, technical assistance and funding. This collaborative response provides developing countries with efficient access to a wide range of resources to adapt to and mitigate climate change and foster more equitable and sustainable development.

Transformational change is needed to cut emissions and adapt to a changing climate, all while meeting development needs. Such change requires ground-breaking coordination to mobilize resources globally, with speed and scale. Through the NDC Partnership, countries draw upon members' expertise and funding, turning their NDCs into actionable policies, programs and projects.



## The NDC Partnership is Country-Driven and Member-Led

Through a unique model of collaboration, the NDC Partnership brings together developed and developing countries, major international institutions and non-state actors to bridge country needs with member resources and fast-track results. To guide their engagement with the NDC Partnership, members appoint Focal Points: senior representatives of a country or institution who assume responsibility for internal coordination. Focal points typically represent ministries responsible for addressing climate change and development or heads of agencies and organizations.

Representative of its diverse membership, the NDC Partnership is led by two Co-Chairs, at the ministerial level and actively guided by a Steering Committee, which provides strategic guidance to ensure that the NDC Partnership achieves the objectives of the NDC Partnership Work Program.

The Support Unit is hosted by the United Nations Framework Convention on Climate Change (UNFCCC), the United Nations Office for Project Services (UNOPS) and World Resources Institute (WRI).

As countries foster enabling environments for strong climate action, the NDC Partnership supports them in effectively mobilizing finance to implement their priorities. We work to mobilize resources from countries and institutions and to ensure they complement one another, are used efficiently and are leveraged to deliver specific, tailored and robust support packages. We harness and streamline technical and financial assistance, deliver capacity building and accelerate knowledge exchange. Governments benefit from the resources and expertise of a wide range of partners, each bringing unique strengths.
