




The NDC Partnership is a global coalition of countries and institutions collaborating to drive transformational climate action through sustainable development.



INTRODUCTION

In 2015, the world endorsed the Paris Agreement and the 2030 Agenda for Sustainable Development. Nations signal their commitments to the Paris Agreement through Nationally Determined Contributions (NDCs)—each country’s strategy to cut its own greenhouse gas emissions and build resilience against the negative effects of a changing climate. The Partnership advances the goals of the Paris Agreement by bringing together countries and institutions in new ways to accelerate NDC implementation and enhance ambition over time. Through a country-driven approach, we drive climate action and sustainable development while supporting countries in reducing social and economic inequalities. The Partnership responds flexibly to country needs as they evolve, keeping the momentum for strong climate action even in the challenging economic circumstances countries face today.

WHO WE ARE

The Partnership has grown to more than 180 members, including developed and developing countries as well as major international institutions and non-state actors. Members appoint Focal Points (senior representatives of their respective country or institution who assume responsibility for internal coordination) to guide their engagement in the Partnership. Country Focal Points represent ministries responsible for addressing climate change and development, typically the Ministry of Environment and the Ministry of Finance or Planning. If desired, a country may nominate Focal Points from all three ministries.

The Partnership is governed by an active Steering Committee which represents the diverse membership. Our work is facilitated by a Support Unit based at World Resources Institute in Washington, DC and the UNFCCC Secretariat in Bonn, Germany.

HOW WE WORK

The NDC Partnership is founded on ten guiding principles to which all members commit. Our guiding principles provide the foundation for member collaboration as we work to accelerate and scale up NDC implementation and sustainable development.

MOBILIZING CLIMATE AND DEVELOPMENT ACTION ACROSS GOVERNMENT AND SOCIETY

We deploy our **Country Engagement Strategy** in response to requests for support from country members, to coordinate, align, and maximize support among members. We support countries to bring climate and development goals together within their broader sustainable development agendas by turning NDCs from stand-alone documents into national policies and implementation plans. These NDC implementation strategies, sometimes known as Partnership Plans, are public, government-owned documents detailing priority actions for NDC implementation and tracking partner support for those actions. They are developed with the engagement of a wide range of stakeholders. Focal Points serve as government representatives in the Partnership, taking ownership and directing the elaboration of their country's NDC implementation plans.

RAISING COUNTRY CLIMATE AMBITION

Under the Paris Agreement, countries revise their NDCs every five years to cut greenhouse gas emissions and implement solutions to adapt to the effects of climate change. Through the **Climate Action Enhancement Program (CAEP)**, the NDC Partnership delivers targeted support to countries to enhance the quality, increase ambition, and fast-track implementation of NDCs.

CLIMATE AT THE HEART OF RECOVERY PACKAGES

Linking climate action with development priorities is one of the Partnership's foundational principles. We routinely support member countries to align climate priorities with development plans and budgets.

Current circumstances underscore the importance of aligning NDCs with social and economic priorities. To support countries in their planning for climate-resilient recovery from COVID-19 impacts, the NDC Partnership launched the **Economic Advisors Initiative** in July 2020. The initiative allows the Partnership to deploy economic advisors to Ministries of Finance or Planning to help shape recovery packages. To facilitate ongoing learning, the advisors and member countries can participate in a Green Recovery Network and leverage specialized expertise offered by a Thematic Expert Group comprised of institutional and associate Partnership members.

CATALYZING CLIMATE FINANCE

The Partnership supports members to mobilize and guide public and private finance through its in-country activities and knowledge resources. The Partnership also supports countries to prioritize, prepare, and communicate investment needs to potential financing partners; to develop strategies and policies that build enabling environments; and to offer an organized set of information resources and tools to help countries learn how to access finance from diverse sources.

PROMOTING KNOWLEDGE EXCHANGE

The Partnership supports nations in achieving their climate goals by increasing access to knowledge resources and building a peer community around the experiences of countries implementing their NDCs. The NDC Partnership takes lessons learned from its in-country work, as well as insights from its broad network of partners, and shares them to accelerate NDC implementation across its membership and beyond.



ENGAGING ON THE GROUND

More than 70 developing countries are receiving support to implement and enhance their NDCs from more than 100 implementing partners (representing both members and non-members).

73 countries (listed below) are receiving Partnership support through our Country Engagement Strategy. In addition, the Partnership's Climate Action Enhancement Package (CAEP) is supporting 63 countries with the collective effort of 46 partners, deploying USD45.5 million, including USD23.8 million from the Partnership's Technical Assistance Fund and more than USD21.7 million from partners' own resources. Finally, a total of 16 NDC Partnership members are providing advisors to 32 developing country members that have requested support to integrate NDCs in the heart of recovery packages.
